1.10	by the mother or father before a notary public and filed with the state registrar of vital
1.11	records within the earlier of 60 days after the recognition is executed or the date of an
1.12	administrative or judicial hearing relating to the child in which the revoking party is a party
1.13	to the related action. For purposes of this section, an "administrative or judicial hearing"
1.14	means a hearing where the revoking party has been served with a notice of the hearing and
1.15	had an opportunity to be heard at such hearing. A joinder in a recognition may be revoked
1.16	in a writing signed by the man who executed the joinder and filed with the state registrar
