1.10	seasonal-recreational property is \$41,690,000 for taxes payable in 2020 and thereafter. The
1.11	tax under this section is not treated as a local tax rate under section 469.177 and is not the
1.12	levy of a governmental unit under chapters 276A and 473F.
1.13	The commissioner shall increase or decrease the preliminary or final rate for a year as
1.14	necessary to account for errors and tax base changes that affected a preliminary or final rate
