1.7	consultation with the commissioner of health, shall appoint the following voting members

1.9	(1) two consumer members who have been impacted by an opioid abuse disorder or
1.10	opioid dependence disorder, either personally or with family members;
1.11	(2) one member who is a licensed physician actively practicing in Minnesota and
1.12	registered as a practitioner with the DEA;
1.13	(3) one member who is a licensed pharmacist actively practicing in Minnesota and
