1.5	Section 1. Minnesota Statutes 2020, section 65B.48, subdivision 5, is amended to read:
1.6	Subd. 5. Motorcycle coverage. (a) Every owner of a motorcycle registered or required
1.7	to be registered in this state or operated in this state by the owner or with the owner's
1.8	permission shall provide and maintain security for the payment of tort liabilities arising out
1.9	of the maintenance or use of the motorcycle in this state. Security may be provided by a
1.10	contract of liability insurance complying with section 65B.49, subdivision 3, or by qualifying
1.11	as a self insurer in the manner provided in subdivision 3.
1.12	(b) At the time an application for motorcycle insurance without personal injury protection
1.13	coverage is completed, there must be attached to the application a separate form containing
1.14	a written notice in at least 10-point bold type, if printed, or in capital letters, if typewritten
1.15	that states:
1.16	"Under Minnesota law, a policy of motorcycle coverage issued in the State of Minnesota
1.17	must provide liability coverage only, and there is no requirement that the policy provide
1.18	personal injury protection (PIP) coverage in the case of injury sustained by the insured.
1.19	No PIP coverage provided by an automobile insurance policy you may have in force
