3.14	(b) The prosecutor shall make a good faith and reasonable effort to notify any person
3.15	determined to be a victim of the offense for which adjustment is sought of the existence of
3.16	a petition. Notification under this paragraph does not constitute a violation of an existing
3.17	order for protection, restraining order, or other no contact order.
3.18	(c) Notice to victims of the offense under this subdivision must:
3.19	(1) specifically inform the victim of the right to object, orally or in writing, to the
3.20	proposed adjustment of sentence; and
3.21	(2) inform the victims of the right to be present and to submit an oral or written statement
3.22	at the hearing described in subdivision 6.
3.23	(d) If a victim notifies the prosecutor of an objection to the proposed adjustment of
3.24	sentence and is not present when the court considers the sentence adjustment, the prosecutor
3.25	shall make these objections known to the court.
3.26	Subd. 6. Hearing. (a) The court shall hold a hearing on the petition no sooner than 60
3.27	days after service of the petition. The hearing shall be scheduled so that the parties have
3.28	adequate time to prepare and present arguments regarding the issue of sentence adjustment.
3.29	The parties may submit written arguments to the court prior to the date of the hearing and
3.30	may make oral arguments before the court at the hearing. The individual on whose behalf
3.31	the petition has been brought must be present at the hearing, unless excused under Minnesota
3.32	Rules of Criminal Procedure, rule 26.03, subdivision 1, clause (3).

4.1	(b) A victim of the offense for which sentence adjustment is sought has a right to submit
4.2	an oral or written statement to the court at the time of the hearing describing the harm
4.3	suffered by the victim as a result of the crime and the victim's recommendation on whether
4.4	adjustment should be granted or denied. The judge shall consider the victim's statement
4.5	when making a decision.
4.6	(c) Representatives of the Department of Corrections, supervising agents, community
4.7	treatment providers, and any other individual with relevant information may submit an oral
4.8	or written statement to the court at the time of the hearing.
4.9	Subd. 7. Nature of remedy; standard. (a) The court shall determine whether there are
4.10	substantial and compelling reasons to adjust the individual's sentence. In making this
4.11	determination, the court shall consider what impact, if any, a sentence adjustment would
4.12	have on public safety, including whether an adjustment would promote the rehabilitation
4.13	of the individual, properly reflect the severity of the underlying offense, or reduce sentencing
4.14	disparities. In making this determination, the court may consider factors relating to both the
4.15	offender and the offense, including but not limited to:
4.16	(1) the individual's performance on probation or supervision;
4.17	(2) the individual's disciplinary record during any period of incarceration;
4.18	(3) records of any rehabilitation efforts made by the individual since the date of offense
4.19	and any plan to continue those efforts in the community;
4.20	(4) evidence that remorse, age, diminished physical condition, or any other factor has
4.21	significantly reduced the likelihood that the individual will commit a future offense;
4.22	(5) the amount of time the individual has served in custody or under supervision; and
4.23	(6) significant changes in law or sentencing practice since the date of offense.
4.24	(b) Notwithstanding any law to the contrary, if the court determines that there are
4.25	substantial and compelling reasons to adjust the individual's sentence, the court may modify
4.26	the sentence in any way provided the adjustment does not:
4.27	(1) increase the period of confinement or, if the individual is serving a stayed sentence,
4.28	increase the period of supervision;
4.29	(2) reduce or eliminate the amount of court-ordered restitution; or
4.30	(3) reduce or eliminate a term of conditional release required by law when a court
4.31	commits an offender to the custody of the commissioner of corrections.
4.32	The court may stay imposition or execution of sentence pursuant to section 609.135.
