121A.55 POLICIES TO BE ESTABLISHED.

(a) The commissioner of education shall promulgate guidelines to assist each school 2.9 board. Each school board shall establish uniform criteria for dismissal and adopt written 2.10 policies and rules to effectuate the purposes of sections 121A.40 to 121A.56. The policies 2.11 shall emphasize preventing dismissals through early detection of problems and shall; 2.12 avoid using suspension and expulsion from school until alternatives have been tried under 2.13 section 121A.575, except where it appears to the school administrator that the pupil will 2.14 create an immediate and substantial danger to self or surrounding persons or property; be 2.15 designed to address prevent students' inappropriate behavior from recurring; and include 2.16 strategies to reengage the student in learning. The policies shall recognize the continuing 2.17 responsibility of the school for the education of the pupil during the dismissal period and 2.18 during the period when an agreement of parents to withdraw a child from school as an 2.19 alternative to expulsion is in effect. The alternative educational services, if the pupil 2.20 wishes to take advantage of them, must be adequate to allow the pupil to make progress 2.21 towards meeting the graduation standards adopted under section 120B.02 and help prepare 2.22 the pupil for readmission. 2.23

(b) An area learning center under section 123A.05 may not prohibit an expelled or
excluded pupil from enrolling solely because a district expelled or excluded the pupil. The
board of the area learning center may use the provisions of the Pupil Fair Dismissal Act to
exclude a pupil or to require an admission plan.

(c) Each school district shall develop a policy and report it to the commissioner on
the appropriate use of peace officers and crisis teams to remove students who have an
individualized education program from school grounds.
