- 1.1 A bill for an act
- 1.2 relating to human services; modifying medical assistance requirements for persons
- 1.3 needing treatment for breast or cervical cancer; amending Minnesota Statutes 2018,
- 1.4 section 256B.057, subdivision 10.
- 1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
- 1.6 Section 1. Minnesota Statutes 2018, section 256B.057, subdivision 10, is amended to read:
- 1.7 Subd. 10. **Certain persons needing treatment for breast or cervical cancer.** (a)
- 1.8 Medical assistance may be paid for a person who:
- 1.9 (1) has been screened for breast or cervical cancer by ~~the Minnesota~~ any Centers for
- 1.10 Disease Control and Prevention (CDC) National Breast and Cervical Cancer Early Detection
- 1.11 Program (NBCCEDP)-funded breast and cervical cancer control program, and program
- 1.12 funds have been used to pay for the person's screening;
- 1.13 (2) according to the person's treating health professional, needs treatment, including
- 1.14 diagnostic services necessary to determine the extent and proper course of treatment, for
- 1.15 breast or cervical cancer, including precancerous conditions and early stage cancer;
- 1.16 (3) meets the income eligibility guidelines for ~~the Minnesota~~ any CDC NBCCEDP-funded
- 1.17 breast and cervical cancer control program;
- 1.18 (4) is under age 65;
- 1.19 (5) is not otherwise eligible for medical assistance under United States Code, title 42,
- 1.20 section 1396a(a)(10)(A)(i); and
- 1.21 (6) is not otherwise covered under creditable coverage, as defined under United States
- 1.22 Code, title 42, section 1396a(aa).

2.1 (b) Medical assistance provided for an eligible person under this subdivision shall be  
2.2 limited to services provided during the period that the person receives treatment for breast  
2.3 or cervical cancer.

2.4 (c) A person meeting the criteria in paragraph (a) is eligible for medical assistance  
2.5 without meeting the eligibility criteria relating to income and assets in section 256B.056,  
2.6 subdivisions 1a to 5a.
