Be it enacted by the Legislative Assembly of the Territory of Minnesota:

SECTION I. That O. W. Streeter, his heirs, executors, administrators Bight to cetab or assigns, shall have the exclusive right and privilege, of keeping and maintaining a ferry across the Mississippi River, in Houston county, at a point to be selected by him in Section eleven (11) Township one hundred and four, (104) N. R. four (4) west of the 5th principal Meridian, for the period of fifteen years, and no other ferry shall be established within one mile either above or below said Point.

That the said O. W. Streeter shall at all times keep a safe what kind boat or boats, in good repair, sufficient for the accommodation of all persons wishing to cross said ferry, and shall give prompt and ready attendance on passengers and teams on all occasions, and at all hours, both at night or day; but persons wishing to cross at said ferry (at night) after 9 o'clock may be charged double the fare as hereinafter prescribed.

Bonds required.

SEC. 4. The said O. W. Streeter shall, within six months after the passage of this act, file or cause to be filed with the clerk of the board of county commissioners of Houston county, a bond to the said board of commissioners with two or more good, sufficient sureties, to be approved by the said Commissioners in the penal sum of five hundred dollars, conditioned that they will fulfil all the duties that are imposed upon them in the foregoing sections; and in case of their failure or neglect so to do, they shall forfeit all the benefits that might have accrued to them from the passage of this act.

Gensequence of not keeping a good boat.

SEC. 5. For every neglect in keeping good and sufficient boats, or failure to give prompt and due attendance, the said O. W. Streeter, shall forfeit a sum not exceeding ten dollars, to be recovered by a civil action before any court having competent jurisdiction.

Remedy of injured parties, SEC. 6. Any person who shall sustain any injury by the negligence of the said O. W. Streeter, or any ferryman in his employ, may have a remedy on the bond required by this act.

SEC. 7. Nothing in this act contained shall interfere with any right or heense that may heretofore have been lawfully granted by any County Commissioners authorized under the act of March 3d, 1854.
