An act to legalize the acts of the County and Precinct Officers in Wabashaw County.

Section 1. Legalizing acts of officers,

Organizing the County of Wabashaw.
Terms of District Court.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

SECTION 1. That the acts of the county and precinct officers, who have Acts of officers. heretofore acted as such in the county of Wabashaw in the years A. D. 1854 and 1855, are hereby declared to be as legal and valid as if the said county and precinct officers in the said county had been duly elected, and were legally entitled to hold and exercise the said offices.

SEC. 2. That the said county of Wabashaw is hereby duly organized Wabashaw for Judicial purposes.

There shall be held in the said county of Wabashaw two terms courts. of the District Court in each and every year.

SEC. 4. The time of holding said District Court shall be fixed by the When held. Judge of the said District Court.

Sec. 5. This act shall take effect from and after its passage.

CHAPTER XXIV.

An Act for the Relief of School Districts.

SECTION 1. Authorizing the Trustees of School Districts to draw from the County Treasury.

Duty of County Treasurers.

When to be in force.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

SECTION 1. That the Trustees of the several districts of said Territory Trustees. are hereby authorized to draw from the Treasury of the county in which they are situated, all school monies due the same respectively, and all monics to become due, at the time they so become due, in such sums, and at such times as they may deem necessary for defraying the actual expenses

needed for holding schools therein, and for necessary repairs of the school house, to be expended for these purposes and none other; Provided, that they first retain from such sum so drawn as aforesaid, a sufficient amount of money to pay teachers' wages for the length of time which the district decided at their annual meeting, to have school kept therein during the vear.

Treasurers.

SEC. 2. It is hereby made the duty of all County Treasurers of said Territory, to pay over, upon the draft of the Trustees of school districts in his county entitled to the same, the amount expressed in said draft, forthwith; Provided, the same does not exceed the amount due such district at the time the said draft is presented.

To be in force.

SEC. 3. This act shall take effect from and after its passage.

CHAPTER XXV.

An act to change the time of holding Courts in the County of Le Sueur.

Times of holding Court in Le Suer County. Section 1.

All complaints, processes, &c., to be acted upon by the court.

When to be in force.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

Time for holding Court.

SEC. 1. The term of the District Court for the third Judicial District within and for the county of Le Sueur, now held on the third Monday of May in each year, shall hereafter be held on the third Monday of April, annually, and so much of all acts inconsistent with the provisions of this act, are hereby repealed.

Complaints, &c., to be heard.

Sec. 2. All complaints, processes, precepts, recognizances and reports of every kind whatever, commenced for, pending in, or returnable to, the next term of said Court, for and within said county held as aforesaid, shall be returnable to, have day in, and be acted upon by said Court, at the terms thereof established by the first section of this act.

To be in force.
