

CHAPTER VII.

An Act Authorizing the collector of taxes to assess real estate and other property in certain cases.

SECTION 1. Collector to collect taxes on unassessed property.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

May assess and
collect taxes.

SECTION 1. That it is hereby made the duty of the Collector of taxes to assess all real estate and other property within his knowledge, which may have been subject to taxation but not assessed by the Assessors, and to levy and collect the tax on the same, and to make a correct return to the Board of County Commissioners of all the property so assessed, and the taxes he may have collected on the same.

CHAPTER VIII.

A bill for an act to constitute the county of Hennepin a part of the Second Judicial District of the Territory of Minnesota, and for other purposes.

- SECTION 1. Hennepin county a part of Second Judicial District.
2. County of Meeker attached to Carver for judicial purposes.
3. Acts inconsistent repealed.
4. When to be in force.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

Hennepin county.

SECTION 1. That the county of Hennepin shall constitute a part of the second judicial district of said Territory.

Meeker county.

SEC. 2. That the county of Meeker shall be attached to the county of Carver for judicial purposes.

Acts repealed.

SEC. 3. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage. To be in force.

CHAPTER IX.

An Act to amend the eighth section of an act entitled "An act providing for the appointment of a Librarian, and for other purposes."

SECTION 1. Times of opening Library Room.

Be it enacted by the Legislative Assembly of the Territory of Minnesota :

SECTION 1. That section eight of the above entitled act be so amended as to read as follows:—"The Library shall be kept open during the session of the Legislature and of the Supreme Court, from the hour of nine o'clock A. M. until twelve o'clock M., and from two until nine o'clock P. M. All other times, on every Wednesday and Saturday, during the ordinary business hours. The hours to be selected and notice thereof to be posted on the outside of the door of the Library room by the Librarian.
