A Memorial of the Legislative Assembly of the Territory of the United States for the Reduction of the Military Reserve at Fort Ripley.

The Memorial of the Legislative Assembly of the Territory of Minnesota respectfully represents:

Reduction of
Military Reserve.

That the Military Reserve at Fort Ripley is, at this time, not needed for military purposes, in the opinion of your Memorialists, and it would, if reduced, be immediately settled upon by a farming population of citizens.— That portion of the Reserve which lies on the east of the Mississippi, includes but little timber that is of value to the Military post, even if it needed it, which it does not, and if opened for settlement, would, the whole of it, be bought up and occupied.

Your Memorialists would therefore most respectfully pray that the Military Reserve be reduced to one mile square, on the west branch of the Mississippi river; and as in duty bound your Memorialists will ever pray, &c.

Memorial to the Post Master General of the United States for the establishment of a Mail Route from Wabashaw, by the way of Greenwood, Rochester, and High Forest to Austin.

Memorial for
mail route

To the Honorable the Postmaster General of the United States: The memorial of the Legislative Assembly of the Territory of Minnesota respectfully represents that there is no mail facility from the town to Wabashaw, in Wabashaw county, to the town of Austin, Mower county, on the Red Cedar, except by the way of West Union, Iowa; that the towns of Green Wood and High Forest are totally destitute of mail service. The distance from Wabashaw to Greenwood, is sixteen miles; from Greenwood to Rochester, sixteen miles; Rochester to High Forest, eighteen miles; from High Forest to Austin, twenty-five miles; a distance of seventy-five miles through a thickly populated country.

That your memorialists feel a strong reliance upon the wishes of the

Postmaster General of the United States to render all proper mail facilities to the people of this Territory, whenever their wants are made known.

And with this conviction your memorialists would respectfully ask that a weekly route may be established, viz: From Wabshaw, by the way of Green Wood, Rochester, and High Forest, to Austin, Mower county, Minnesota Territory.

Memorial to the Post Master General for a Mail Route from St. Paul to West Union.

To the Honorable Post Master General of the United States: The memorial of the Legislative Assembly of the Territory of Minnesota respectfully represents, That the routes on which the mails are now carried are not sufficiently extensive to afford our population the necessary mail facilities, in consequence of the immigration into our Territory during the last year.

Sec. 2. That your memorialists, believing that it is the desire of Congress to render to the people of this Territory all proper Mail facilities, when the wants of the community are made known, would most respectfully ask, that the following route may be established during the present session of Congress: From St. Paul, by way of Cannon Falls, Mantorville, Pleasant Valley, Frankford, Forrestville, in Minnesota, and Itme Spring, New Oregon and Fort Atkinson, to West Union, in Iowa.
