CHAPTER XXVIII.

An Act to change the name of Baltus Simmons.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

SECTION 1. That the name of Baltus Simmons be and the

same is hereby changed to George W. Lay.

SEC. 2. That by the name of George W. Lay the said Simmons may hereafter lawfully transact all lawful business, take, receive, hold, sell and transfer real estate, in the same manner and with the same effect and force as he might have lawfully done in his own name had not this act passed and become a law.

CHAPTER XXIX.

An Act to amend an Act, entitled "An Act to grant the right to certain Persons to Establish and Maintain Ferries in this Territory," approved March 1st, 1856.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

Section 1. That the sixth line in section nine of said Act, be amended by striking out the words "on or before the first day of September, A D. eighteen hundred and fifty-six," and inserting in lieu thereof, the words "on or before the first day of September, eighteen hundred and fifty-seven."

SEC. 2. That the term for which a charter was granted Wm. W. Sweeney, William Lauver, Richard Freeborn and Norris Hobart, to establish and maintain a Ferry across the

main channel of the Mississippi river, shall commence from the date of the approval of this amendatory Act.

CHAPTER XXX.

A Bill Authorizing the legal Voters of Wright County to designate the place for County Seat of said County.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

Section 1. That at the annual election in October next the legal voters of Wright County shall meet at their respective places of voting, and proceed, as in other elections, to select some town, village, or city, which shall be the county seat of said county, and the town, village, or city which shall receive the highest number of legal votes shall be declared by the Register of Deeds to whom the returns of said election shall be made, the county seat of said county. The place voted for shall be written or printed on each ballot.

SEC. 2. That a copy of this act shall be forwarded immediately on its passage by the Secretary of the Territory to the Sheriff of said county, who shall proceed to post up notices of said election in three public places within each pre-

cinct in said county.
