CHAPTER CIV.

An Act to amend an Act entitled An Act granting Thos. McRoberts the right to establish and maintain a Ferry across the Mississippi River at La Crescent, Approved the 7th of February, 1857.

- SECTION 1. Amendment to Section 1 of former Charter-Change of location of Ferry.
 - 2. Amendment to Section-Repealing all acts condicting with Section 1.
 - Amendment to Section 8—Provision exempting from running boat at certain seasons.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the first Section in the Act granting to Thos. McRoberts the right to establish and maintain a Ferry across the Mississippi River at La Crescent, be and is hereby Change of leamended by striking out all after the words "village of La Crescent," and insert the following, viz: or at any point on fractional Sections two (2), three (3), eleven (11), twelve (12), thirteen (13), fourteen (14) and twenty-four (24), in township one hundred and four (104), north of range four west, in Houston County, State of Minnesota, for the period of fifteen years, and no Ferry shall be established within one mile and a half above or below the foregoing described limits.

SEC. 2. That Section seven (7) in said Act, be and is hereby amended so as to contravene and repeal all acts conflicting with Section one in this amendatory Act, except so conflicting much of Section seven (7), as relates to the rights of the Winona and La Crosse Rail Road Company.

SEC. 3. That Section eight in said Act be and is hereby amended so as to substitute the following, viz: That said McRoberts, his heirs, Executors, Administrators or assigns, Keeping open shall not be required to run a boat or boats after the season of ferry of navigation has closed, nor shall the said McRoberts or his Assigns, &c., be required to run a boat during dangerous winds or storms, or upon the Sabbath, and for all ferrying done in or through ice, during the closing and opening season of navigation, the said McRoberts or his assigns may charge double the rates now fixed by said Act; and this Act to take effect from and after its passage.

CHAPTER CV.

An Act to legalize the survey of the Town of Minneiska.

SECTION 1. Survey and plat of town of Minneiska legalized. 2. Act takes effect on passage.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. The survey and plat of the town of Minneiska, Wabashaw County, made by N. F. Hilbert, and recorded in the Register of Deeds office for said county, October 30, 1856, is hereby declared to be the legal survey and plat of said town.

SEC. 2. This Act shall take effect and be in force from and after its passage.
