

CHAPTER CXI.

An Act supplemental to An Act relative to "An improvement in the City of St. Paul," approved May 23, 1857, and to amend the same.

- SECTION 1. Vacation of the road authorized as a continuation of Fort street to Fort Snelling.
2. Commissioners appointed to carry out provisions of this Act, and to locate and lay out a road between the points designated.
 3. Commissioners heretofore appointed prohibited from further action.
 4. County Board of Supervisors invested with the same authority as County Commissioners under former act.
 5. Act takes effect on passage.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the public street or road heretofore established by the Commissioners appointed under an act, entitled a "Bill relative to an improvement in the City of St. Paul," approved May twenty-three, eighteen hundred and fifty-seven, from the present westerly termination of Fort street in said city, to the westerly limits of said city; and thence to the ferry landing opposite Fort Snelling on the Mississippi, along said line between the termini aforesaid, be, and the same is hereby vacated.

SEC. 2. That D. A. J. Baker, John Smith and Isaac Rose, be, and the same are hereby appointed Commissioners to execute and carry out the requirements of said Act, so far as the same relates to the extension of Fort street, on aforesaid line, from the present westerly termination of said street to the present westerly limits of said city; thence to the ferry landing opposite Fort Snelling, and they shall proceed within twenty days from the passage of this Act, also lay out and establish the said public street or road, and shall lay out the same on the most direct practicable route, and shall proceed in the same manner, in all respects, as is provided for the Commissioners, to be appointed by the District Judge, named in said Act, and shall make a return of their doings in the manner therein prescribed.

SEC. 3. The Commissioners heretofore appointed by the District Judge, to execute the requirements of said Act, are hereby prohibited from taking any further action under the said Act, so far as relates to the said extension of Fort street.

SEC. 4. The County Board of Supervisors are hereby authorized to act in all cases where the said Act authorizes

SEC. 5. This Act shall take effect from and after its passage.

CHAPTER OXII.

An Act for the protection of Fish in Lake Como.

- SECTION 1. Fishing by seine or net in Lake Como prohibited.
 2. Jurisdiction of cases of violation; penalty on conviction.
 3. Fishing in any manner prohibited until after June 1, 1860; penalty for violation.
 4. Act takes effect on passage.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. From and after the passage of this Act it shall be unlawful for any person or persons to take fish from the waters of Lake Como, in Ramsey County, by means of any seine gil-net, scoop-net or any other kind of net whatsoever.

Fishing by seine or net prohibited

Violation—penalty

SEC. 2. Any Justice of the Peace in the County of Ramsey shall have jurisdiction of all cases arising under the provisions of this Act, and upon conviction of any person for violating the same shall impose upon such offender a penalty or fine of not less than twenty-five dollars, nor more than fifty for the first offence, and not less than fifty, nor more than one hundred dollars, for each subsequent offence, one-half of such fine to be paid to the informer, and the remainder to the county treasurer, to be applied to the support of common schools in the County of Ramsey.
