SECTION I. Amendment to Chap. 10, concerning the time of assembling of Road Commissioners.

Be it enacted by the Legislature of the State of Minnesota:

Amendment cerning the time of assembling of road

Section 1. That Section Two of an Act entitled An Act to provide for the location of a State road from Chatfield in Fillto chap 10 con more county, to Winnebago City in Faribault county, and approved March 8th, A. D. 1953, be amended so as to read as follows: That said Commissioners shall meet at Chatfield commissioners on or before the first Monday in October, A. D. 1858, and proceed to discharge the duties imposed upon them by the provisions of this Act, Provided, however, That in the absence of any one of said Commissioners appointed by this Act, the others may have power to supply said vacancy, by appointing another Commissioner, or may in case a majority of them meet proceed to discharge their duties.

An Act to amend an Act entitled An Act to establish the County of Kanabec.

SECTION 1. Amendment to the Boundaries of Kanabec County.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That Section One of H. of R. No. 26, (Chapter Amendment to 54, page 166,) an Act to establish the County of Kanabec, the boundaries approved March 13, 1858, shall read as follows: that so of Kanabec ... much of the county of Pine and State of Minnesota, as lies county within the following boundaries, be and the same is hereby established as the county of Kanabec: beginning at the southeast corner of township thirty-eight (38), range twenty-three (23) west; thence west to the south-west corner of township thirty-eight (38), range twenty-five (25) west, thence north to the north-west corner of township forty (40), range twentyfive (25) west; thence east to the south-west corner of township forty-one (41), range twenty-four (24) west; thence north to the north-west corner of township forty-two (42), range twenty-four (24) west; thence east to the north-east corner of township forty-two (42), range twenty-two (22) west; thence south to the south-east corner of township fortyone (41), range twenty-two (22) west; thence west to the
