CHAPTER CXXXVL

An Act to amend an Act entitled An Act to establish the County of Kanabec.

SECTION 1. Amendment to the Boundaries of Kanabec County.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That Section One of H. of R. No. 26, (Chapter Amendment to 54, page 166,) an Act to establish the County of Kanabec, the boundaries approved March 13, 1858, shall read as follows: that so of Kanabec ... much of the county of Pine and State of Minnesota, as lies county within the following boundaries, be and the same is hereby established as the county of Kanabec: beginning at the southeast corner of township thirty-eight (38), range twenty-three (23) west; thence west to the south-west corner of township thirty-eight (38), range twenty-five (25) west, thence north to the north-west corner of township forty (40), range twentyfive (25) west; thence east to the south-west corner of township forty-one (41), range twenty-four (24) west; thence north to the north-west corner of township forty-two (42), range twenty-four (24) west; thence east to the north-east corner of township forty-two (42), range twenty-two (22) west; thence south to the south-east corner of township fortyone (41), range twenty-two (22) west; thence west to the

north-east corner of township forty (40), range twenty-three (23) west; thence south to the place of beginning. The county seat of said county is hereby located at Brunswick.

CHAPTER CXXXVIL

An Act Locating a State Road.

Section 1. Location of a State Road from Blue Earth City to Wilton.
2. Per diem of Commissioners.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That George F. Batchelder, of Faribault, Rice state road from county, James W. Clarke, of St. Mary, Waseca county, and Blue Earth City Jarvis Herrington, of Blue Earth City, Faribault county, be and are hereby appointed viewers to locate and establish a State road from a point on the road running from Faribault, in Rice county, to Wilton in Waseca county, at or near the north-east corner of township 107, north of range 23 west, via St. Mary in Waseca county, on the most eligible route by way of Winnebago City, to Blue Earth City in Faribault county, and said viewers are hereby authorized to employ a competent surveyor, two chain-men, and one axe-man, at the expense of the counties through which said road runs.

Per diem of Sec. 2. The per diem to be audited and amounts fixed by commissioners the respective Boards of Supervisors of said counties.
