## CHAPTER CXLIX.

### *An Act to authorize the Register of Deeds of Kandiyohi County to copy from the Records of Meeker County.*

Authority to  
copy records  
from Meeker  
county

- SECTION 1. Authority to copy Records from Meeker County.  
2. Fees for copying, and to be paid by Kandiyohi County.  
3. Act takes effect on passage.

*Be it enacted by the Legislature of the State of Minnesota :*

Fees for copy-  
ing to be paid  
by Kandiyohi  
county

SECTION 1. That it shall be lawful for the Register of Deeds of the County of Kandiyohi to copy from the records of the County of Meeker, all deeds, mortgages and other evidences of titles now remaining, of record, in the County of Meeker, in all cases, where the lands are situated within the County of Kandiyohi.

SEC. 2. That the Register of Deeds of Kandiyohi County shall be entitled to the same fees for the same as he is entitled by law for making original records, to be audited by the proper officer of Kandiyohi County, and paid out of the County Treasury.

Sec. 3. This Act shall take effect and be in force from and after its passage.

## CHAPTER OL.

### *An Act to Incorporate the Town of St. Lawrence.*

- SECTION 1. Boundaries of the Town.  
2. First Town Officers, and their term of office.  
3. Oath of office to be taken.  
4. Town Council required to enter the land embraced in town site.  
5. Town site to be divided and deeded to original owners or claimants.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That so much land in the counties of Scott and Carver as is contained in the Town of St. Lawrence, as <sup>Boundaries</sup> the same is recorded in the office of Register of Deeds for the counties aforesaid, be and the same is hereby created a town corporate by the name of St. Lawrence, with all the privileges and responsibilities usually enjoyed by municipal corporations.

Sec. 2. That S. B. Strait shall be President, and Wm. H. Stodder and Charles L. Pierson, Trustees of said town, with <sup>First town officers—term of office</sup> power to appoint an additional Trustee and a Recorder, who shall hold their offices for one year from the date of the passage of this Act, and until their successors are elected and qualified. And the same shall constitute the Town Council of said town of St. Lawrence; and the said Town Council shall have power to appoint other officers necessary for the good government of the town.

Sec. 3. Each member of the Town Council, before entering upon the duties of his office, shall take an oath or affirmation <sup>Oath of office to be taken</sup> to support the Constitution of the United States, and also an oath of office.
