CHAPTER CLXXIII.

An Act to locate a State Road from Marion to Ashland.

- SECTION 1. Commissioners appointed to locate a State Road from Marion to Ashland.
2. First meeting of Commissioners.
 3. Copy of plat of Road to be deposited with Register of Deeds.
 4. Power of Commissioners to appoint substitutes.
 5. Per diem of Commissioners.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That W. P. Gibson, ——— Little, and Jas. L. Commissioners Hodges, be, and the same are hereby appointed Commission-^{appointed}ers to lay out, mark and survey a State Road from Marion in Olmsted county, to Ashland, in Dodge county.

Sec. 2. The said Commissioners or their substitutes duly ^{Meeting of com}authorized, shall meet at Marion on the second Monday of ^{missioners}September, A. D. 1858, or as soon thereafter as may be practicable, and proceed to survey, mark and lay out said road by the nearest and most feasible route. The expense of laying out and surveying said road shall be paid by the counties through which said road may pass. The Commissioners shall decide the proportion and amount of such expense to be paid by said counties through which said road may pass, and notify the Clerk of the Board of Supervisors of each of said counties of the same.

Sec. 3. The above named Commissioners shall cause to

be deposited in the offices of the Register of Deeds of the counties through which said road may pass a copy of the survey of said road.

May appoint substitutes

SEC. 4. In the event either of said Commissioners shall be unable to perform the duties assigned him in this Act, he shall have power to appoint a substitute, and it shall be his duty to notify the other Commissioners of such substitution: *Provided*, That if at the first meeting mentioned in the Second Section of this bill, either of said Commissioners shall fail to appear in person or by duly authorized substitute, the said appointment shall be declared cancelled, and the Commissioner or Commissioners, or their duly authorized substitute or substitutes there present, shall have the power to select suitable persons to fill such vacancy or vacancies.

Per diem

SEC. 5. That said Commissioners shall be allowed the sum of two dollars per day, for the time necessarily occupied in the location of said road, and they are empowered to employ one surveyor, at two dollars per day, two chain-men and one axe-man at a sum not exceeding one dollar and fifty cents per day.

SEC. 6. This Act shall take effect on and after its passage.
