

county of Goodhue, State of Minnesota, are hereby authorized and fully empowered (two thirds of the members present ^{Authority to} ~~Authority to~~ borrow money voting for the same), to issue County Bonds of said county, to aid in the erection of county buildings in said county, and to any amount not exceeding twenty seven thousand dollars. Which bonds shall be signed by the chairman of said Board, and attested by the clerk of said Board.

SEC. 2. For the purpose of paying the principal and interest to become due on said bonds, and as the same may ^{Tax to be levied} become due, the Board of Supervisors of said county are hereby authorized and empowered to raise by tax, upon the taxable property of said county, in the usual manner of assessing and collecting taxes, a sufficient sum of money, and in such amounts, and at such times as may be necessary.

SEC. 3. The said Board of Supervisors shall determine by vote, as aforesaid, whether they will issue County Bonds for ^{Interest not to exceed 12 per cent} the purposes in this Act specified, at their first or second meeting after the passage of this Act, and shall also at the same time determine the amount of bonds to be issued, the rate of interest, (which shall not exceed twelve per cent. per annum), and the time when said bonds shall be made payable, and to whose order they shall be drawn.

SEC. 4. This Act shall take effect and be in force from and after its passage.

CHAPTER CLXXVII.

An Act to provide for laying out a State Road from Rochester to Wilton.

- SECTION 1. Appointment of Commissioners to lay out State Road from.
2. Meeting of Commissioners. Expenses of laying out road, how paid.
3. Per diem of Commissioners.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That Robert Moffitt, and David A. Shaw, of the

county of Dodge, and N. B. Robbins, Jr, of the county of Olmsted, be, and the same are hereby appointed Commissioners to view and lay out and mark a State Road, beginning at the town of Rochester, in Olmsted county, thence west on the most practicable route to Ashland, in Dodge county, thence west to Wilton, in Waseca county.

Sec. 2. That the said Commissioners or any two them, shall meet at U. C. Coles, in Rochester, on the 25th day of June, A. D. 1858, or as soon thereafter as practicable, and proceed to lay out and mark said road; said Commissioners shall make out a fair and accurate draft of the location of said road, one copy of which shall be deposited in the office of the Secretary of State, on or before the first day of January next, and one copy in the office of Clerk of the Board of County Supervisors of the respective counties through which said road may run, on the time aforesaid, and from thenceforth said road shall be a public highway.

Per diem

Sec. 3. The Commissioners shall be allowed the sum of two dollars per day for every day necessarily employed in performing the duties assigned by this Act, and the said Commissioners are hereby authorized to employ one surveyor at two dollars per day, and two chain-bearers at a sum not exceeding for each, one dollar per day, the expenses of locating said road shall be paid by the counties through which said road may pass.

The Commissioners shall decide the proportion and amount of such expenses, to be paid by said counties through which said road may pass, and notify the Clerk of the Board of Supervisors of each of said counties of the same.

Sec. 4. This Act shall be in force from and after its passage.
