Rates of toll for crossing

SEC. 3. The rates of toll for cressing said bridge shall not exceed the following, viz: For each foot passenger, five cents; for each horse, mare or mule with rider, ten cents; for each one-horse carriage, fifteen cents; for each two-horse, two-ox or two-mulo team, loaded or unloaded, with driver, twenty-five cents; for each additional horse, mule, ox or cow, one cent per head; for each swine, or sheep, or goat, one-half cent per head.

Rates to be posted on bridge SEC. 4. It shall be the duty of said Board of Supervisors to post upon said bridge, in a conspicuous place, the rates of toll authorized to be taken thereon.

Authority to collect toll

SEC. 5. The authority of the County of Brown to collect toll at the said bridge, shall be for the term of ten years, after which time said bridge shall forever after remain free to all travel whatsoever.

SEC. 6. This Act shall take effect and be in force from

and after its passage.

SEC. 2. That said Register of Deeds of the county of Free-Expenses how born, shall receive such compensation for copying said rec-paid ords, and recording them in the county of Freeborn, as the Board of Supervisors of said county may contract for, which compensation shall be paid out of the treasurers office of the county of Freeborn, the said Board of Supervisors first auditing and approving said account.
