CHAPTER CXXII.

An Act to provide for the location of a State Road from Faribault to Mankato.

- SECTION 1. Appointment of Commissioners to lay out State Road.
2. Meeting of Commissioners, and power to appoint substitutes.
3. Expenses of location paid by the counties through which the Road passes.
4. Commissioners to decide upon proportion of expenses to be paid by each county.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That N. S. Messick, David B. Parsons, and David Campbell, be and the same are hereby appointed Commissioners to locate and mark out a State Road commencing at Faribault, in the county of Rice, and from thence by way of Warsaw, Morristown, Waterville and Okamou, on the most practicable route to Mankato in Blue Earth county. ^{Commissioners appointed}

SEC. 2. That said Commissioners shall meet on the first Monday in May, A. D. 1858, or as soon thereafter as convenient at the Barron House in said town of Faribault, and at said meeting shall appoint the time when said road shall be commenced, and in case either of the Commissioners ap- ^{Meeting of com- missioners Power to ap- point sub- stitutes}

pointed by this Act, neglect or refuse to act as such Commissioner, the other Commissioners may appoint some suitable person to supply said vacancy, or may in case a majority of them meet, proceed to discharge their duties as provided in Section First of this Act.

Expenses how paid **Sec. 3.** That each county through which said road shall pass shall pay the expenses incurred in the location of the same as aforesaid, in proportion to the length of said road in each county respectively.

Commissioners to decide expenses

Sec. 4. That a statement of said expenses so incurred, shall be made in writing by said Commissioners which statement shall designate the amount of the same to be so paid by each of said counties, and a copy of which statement shall be furnished by said Commissioners to the Board of County Commissioners of each of said counties, and the orders of the said Road Commissioners upon the Treasurers of each of said counties respectfully, for the amount so designated shall be by said Treasurers paid out of any moneys in the treasuries of said counties respectively.

Sec. 5. This Act shall take effect and be in force from and after its passage.

CHAPTER CXXIII.

An Act to authorise the County Commissioners of Hennepin County to Levy a Tax to build a Bridge across Nine Mile Creek.

- SECTION 1.** Powers of Commissioners to levy a tax to build a bridge.
 2. Supervisors of Bloomington precinct to have charge of work.
 3. Bridge to be built at the least possible expense.

Be it enacted by the Legislature of the State of Minnesota:
