Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That Chapter three of an Act to amend an Act to incorporate the City of Stillwater, approved March 1st, A. Amendia D. 1858, be and the same is hereby amended to read as relation follows:

Amendment to city charter in relation to duties of city serveyor

SEC. 18. The City Surveyor shall cause to be established at some convenient point in a public street, an initial fixed point, from which the street surveys shall be conducted, and whenever the City Council shall establish the grade lines of any streets, alleys, levees or wharves, they shall cause a full record to be made of the elevations, and all other matters that they may deem necessary for a full understanding in regard to said grades, in a book to be kept for that purpose, by the City Surveyor, and whenever the grades of any

streets, alleys, levees or wharves have been established and recorded, the grades so established and recorded shall not be changed. Provided, That any change may be made by the payment of all damages that may arise to any person or persons interested, said damages to be ascertained in like manner as for deep cutting or extraordinary filling of streets, as provided for in Section 10 of Chapter 4 of this Act. Provided, That nothing herein shall be so construed as to affect any right obtained under any former act or acts of the City Council.
