An Act to provide for the construction of a State Road from Faribault to Wilton.

Board of Commissioners.

Meeting of Board. Appoint substitute. Expenses to be paid by the several counties. File plat of said road. 3,

Take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That Charles Williams, Alonzo Barnum and E. Commissioners J. Crandell, and the same be hereby appointed Commissioners, to locate and open out a State Road from Faribault, Rice County, on the nearest and most practicable route to Wilton,

SEC. 2. That said Commissioners shall meet as soon as convenient, after the passage of the Act, and at said meeting shall appoint the time when the location of said road shall be commenced and may adjourn from time to time as may be requisite. And in case either of the Commissioners above named neglect or refuse to act as such Commissioner, the 'Appoint sub-other Commissioners may supply the vacancy by the appointment of some suitable person, who shall have the same authority as is by this Act conferred upon either of said Commissioners above named.

SEC. 3. That each county through which the said road shall Expense pass, shall pay the expenses incurred in the location of the same as aforesaid in proportion to the length of said road in each county respectively.

Sec. 4. Said Commissioners shall file a plat of said road in the Register's office of the respective counties through which said road may run.
