Be it enacted by the Legislature of the State of Minnesota:

Section 1. That all of township one hundred and twenty-one (121), north of range twenty seven (27) west, and that portion of township one hundred and twenty-one (121), north of range twenty-eight (28) west, all of which is now included in, and known as the town of Clearwater in the County of Wright, be, and the same is hereby set apart from said town of Clearwater, and shall be known as the town of Delhi.

Sec. 2. The citizens, legal voters of said town of Delhi, officers, shall assemble at the house of Israel Darkin in said town,

on the first Tuesday of April, A. D. 1860, between the hours of nine and eleven in the forenoon, and proceed to elect the proper officers for said town, which election is hereby declared to be legal and binding; Provided, That the said township officers so elected shall qualify according to law within ten days after said election.

Sec. 3. This act shall take effect from and after its pas-

sage.

The elective officers of said Town shall be, one Mayor, one Justice of the Peace, (who shall be styled Town Justice), and three Trustees, and have the qualification of voters aforesaid, who shall hold their offices for one year, and until their successors shall be elected and qualified. One Town officers to of said trustees shall be elected from and resident of each year. ward. The Mayor of said town, when so elected, shall be President, and the President and the three Trustees so elected and qualified shall constitute the Town Council. Any three members of said Council shall constitute a quorum for the transaction of business pertaining to their duties.
