CHAPTER XXXIII.

An Act to define the boundaries of certain Counties therein named.

SECTION 1. Boundaries of the County of Toomba.
2. County Seat.
3. Boundaries of the County of Otter Tail. County Seat.
4. Boundaries of the County of Breckenridge.
5. Boundaries of the County of Becker.
6. When Act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That so much territory as is comprised in the County of Toumbe following described limits be, and the same hereby is established as the county of Toombs: Beginning at a point where the township line between towns one hundred and thirty-six

and one hundred and thirty-seven north, intersects the western boundary of the State, thence east along said township line between towns one hundred and thirty-six and one hundred and thirty-seven to the range line between ranges fortythree and forty-four west, of town one hundred and thirtysix north, thence south along said range line between ranges forty-three and forty-four west, to the corner of towns one hundred and twenty nine and one hundred and thirty north, thence west between towns one hundred and twenty-nine and one hundred and thirty north to the western boundary of the State, thence northerly along said boundary to the place of beginning.

SEC. 2. The county seat of said county shall be located at county Seat.

Breckenridge.

That an act entitled "An Act to establish the boundaries of certain counties and provide for their organi- County of Otter zation," passed March eighteenth, one thousand eight hundred and fifty eight, be and hereby is so amended as to read as follows: Sec. 1. That so much territory as is embraced in the following described limits be, and the same is hereby created into the county of "Otter Tail:" commencing at the corner of townships one hundred and thirty and one hundred and thirty-one north, of range thirty-five and thirty-six west, of fifth principal meridian; thence north on said range line between ranges thirty-five and thirty-six to the corner of townships one hundred and thirty-seven and one hundred and thirty-eight north, of ranges thirty-five and thirty-six west: thence west along said township line between townships one hundred and thirty-seven and one hundred and thirtyeight north, to the range line between ranges forty-three and forty-four; thence south on the range line between forty-three and forty-four to the corner of townships one hundred and thirty, and one hundred and thirty-one north, of ranges fortythree and forty-four west, thence east along the township line between townships one hundred and thirty and one hundred and thirty-one to the place of beginning. The county seat County East shall be located at "Otter Tail City" till removed by a majority of the voters of the county.

Sec. 4. That so much territory as is embraced in the following described limits be, and the same is hereby created County of Breckinto the county of "Breckenridge."—Beginning at the point where the township line between towns one hundred and thirty-six and one hundred and thirty-seven intersects the right bank of the Red River of the North, thence northerly down the channel of said Red River to the intersection of the line between townships one hundred and forty-four and one hundred and forty-five north, thence east along said township line between townships one hundred and forty-four and one hundred and forty five, to the corner of townships one hundred and forty-four and one hundred and forty-five, ranges forty-three and forty-four west of the fifth principal

meridian; thence south along said range line between ranges forty-three and forty four to the corner of townships one hundred and thirty-six and one hundred and thirty-seven north, ranges forty-three and forty-four west; thence west along said township line between townships one hundred and thirty-six and one hundred and thirty-seven to the place of beginning. The county seat of said county shall be located at "Shayenne City," until removed by a majority of the voters in said county.

SEC. 5. That so much territory as is embraced in the Countrol Bester following described limits, be, and the same is hereby created into the county of "Becker."-Beginning at the northeast corner of Otter Tail county, thence north on range line between ranges thirty-five and thirty-six to corner of townships one hundred and forty-four and one hundred and forty-five north, of ranges thirty-five and thirty-six west of the fifth principal meridian; thence west along said township line between towns one hundred and forty-four and one hundred and forty-five to the northeast corner of Breckenridge county: thence south along the east boundary of said county to the north-west corner of Otter Tail county, thence east along the northern boundary of Otter Tail county to place of beginning. The County Seat of said County is hereby temporarily located at Detroit.

This Act shall take effect on and after its adoption by a majority of the electors of the several Counties herein before mentioned at the next general election.
