

Notice of removal SEC. 5. That if it shall appear that a majority of the votes cast at the April election are for the removal of the County seat, then it shall be the duty of the County Commissioners to cause a notice of such removal to be published in a weekly paper in this State, for at least four weeks.

Terms of office. SEC. 6. And the said commissioners and officers so appointed, as provided in section three of this Act, shall hold their terms of office respectively, until their successors are elected and qualified according to law.

Boundaries submitted to a vote. SEC. 7. That so much of this Act as effects the boundaries of said County, shall be submitted to the citizens of the counties affected thereby, at the next general election, for their approval or rejection; and if a majority voting thereon shall confirm this Act, the boundaries shall be as herein defined.

Repealing clause. SEC. 8. That all acts or parts of acts inconsistent with this act, be, and the same are hereby repealed.

SEC. 9. This act shall take effect from and after its passage.

CHAPTER XXXV.

An Act amending an act entitled "An Act Incorporating the Town of Chatfield."

SECTION 1. Amends section eleven of Act of Incorporation.
2. When to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Section eleven (11) of an act entitled "an Act incorporating the Town of Chatfield" is hereby amended by adding thereto as follows:

"*Seventeenth.* Whenever said Town Council shall deem it necessary to construct or repair any sidewalk within the Town, they shall direct the owners or occupants of any lot

adjoining such sidewalk, to make or repair the same at his or their own cost and charge, and within such time, and in such manner as may be in such direction specified, notice to such owners and occupants, of such direction, being given by publication of the same in a newspaper printed in said Town. If such work is not done in the manner and within the time prescribed, the Town Council shall cause the same to be done at the expense of the lot adjoining said side-walk, whose owners or occupants have neglected or refused to comply with such order." Work done at the expense of lot.

CHAPTER XXXVI.

An Act to attach certain portions of Ramsey and Pine Counties to the County of Aiken.

SECTION 1. Attaches certain territory to the County of Aiken.
2. When Act takes effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all that Territory which originally composed a portion of Ramsey County, and which now adjoins or lies adjacent to the County of Aiken, be, and the same is hereby attached to and made a part of said County of Aiken, and that that Territory which originally composed a portion of the County of Pine, and which now adjoins and lies adjacent to said County of Aiken be, and the same is hereby attached to, and made a part of the said County of Aiken, *Provided*, that the electors of the Counties hereby affected shall, at the next general election after the passage hereof, adopt the same by a majority of such electors. Territory attached to County of Aiken.
