CHAPTER XXX.

An Act to Change the Time of Holding Court in the Sixth Judicial District.

SECTION 1. When and where Courts to be held. 2. Repeal of former acts. 3. All proceedings made returnable to this Court as fixed by the terms of this Act.

4. Act when to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The several terms of the district court for the counties of Faribault, Blue Earth, Nicollet and Mc-Leod, shall be held at the times following :

When and where In the County of Faribault, on the first Wednesday coarts to be held after the first Tuesday of April in each year.

In the County of Blue Earth, on the third Monday of June, and on the first Monday of January of each year, except when the first Monday of January falls on the first day of January, in which case it shall be on the first Tuesday of January.

In the County of Nicollet, on the first Monday of June and on the first Monday of December in each year.

In the County of McLeod, on the fourth Monday of August in each year.

SEC. 2. So much of sub-division six (6) of section one Repeal of former (1) of an act to establish the terms of the district court acts of the State of Minnesota, psssed August 12th, 1858, and all other acts inconsistent with this act, are hereby repealed.

SEC. 3. All writs, recognizances and other proceed-ings made returnable to the district court of any of the ings made resaid counties, shall be considered and deemed to be re- unnable to this turnable to the terms of such court as are fixed by this court Act, and all continuances, and notices made or taken to

CHAPTER XXXI.

An Act Entitled "An Act to Change the Time of Holding the Terms of the District Court in the County of Scott."

SECTION 1. District court—when to be held.
2. All proceedings to be returned to this court as fixed by this Act.
3. Repeal of all acts inconsistent with this Act.

Bo it enacted by the Legislature of the State of Minnesota:

SECTION 1. The general terms of the district court in and for the county of Scott, in the fifth judicial district when to be held shall be held at the times following, to wit: On the second Monday in November and on the third Monday in April in each year.

> SEC. 2. All writs, recognizances, and other proceedings made returnable to said district court, shall be considered and deemed to be returnable to the terms of said court as fixed by this Act, and all continuances and notices, made or taken to any term of said court, shall be deemed to be made or taken to the terms of said court, as the same are fixed by this Act, and all motions and other proceedings noticed to be heard at any regular terin of said court, shall be allowed and considered to be noticed for hearing at the regular terms of such court as fixed by this Act.
