poor house, such removal may be ordered and the actual expenses thereof paid out of the county treasury.

SEC. 6. That the agent aforesaid shall make out and file with the county auditor monthly, and on or before the file with the county auditor monthly, and on or below the first Tuesday of each month, a written statement showing make report the amount furnished for the support of the poor, the name of each person relieved, and in what such relief consisted, whether temporary aid or otherwise, and the time of furnishing the same, and amount to each person or family, and of whom supplies were procured, which statement shall be verified by the oath of such agent; and no account shall be allowed for supplies or articles furnished as aforesaid until the report covering the time embraced therein shall be so made.

SEC. 7. That no account of any person furnishing Accounts for fur-supplies or articles for the support of the poor, on the or-nishing supplies der or authority of said agent or of said commissioners, unless the same is accompanied by an affidavit of the person claiming the same, that the articles therein named were furnished and that such account is in all respects just and correct, shall be allowed.

SEC. 8. This act to take effect and be in force from and after its passage.

## CHAPTER XXX.

An Act to Define the Boundary Lines of Rock and Pipestone Counties.

Boundary lines of Rock county.
Boundary lines of Pipestone county.
Repeal of acts inconsistent with this act.
Act, when to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the boundaries of Rock county be and the same are hereby established as follows, to wit :

Boundary line of Rock county

Beginning at the intersection of the line between townships one hundred and four (104) and one hundred and five (105), with the western boundary of the State; thence eastwardly on said township line to the north east corner of township one hundred and four (104), range forty-four (44); thence southwardly on the line between ranges forty-three (43) and forty-four (44), to the south east corof township one hundred and one (101), range forty-four (44); thence westerly on the line between townships one hundred (100) and one hundred and one (101), following the southern boundary of the State, to its interrection with the western boundary of the State; thence due north, along said boundary to the place of beginning.

That the boundaries of Pipestone county be Sec. 2. and the same are hereby established as follows, to wit:

Boundary line of

this act

Beginning at the intersection of the line between town-Pipertone county ships one hundred and eight (108) and one hundred and nine (109), with the western boundary of the State; thence eastwardly on said township line to the north east corner of township one hundred and eight (108), range fortyfour (44); thence southwardly on the line between ranges forty-three (43) and forty-four (44), to the south east corner of township one hundred and five (105), range fortyfour (44); thence westwardly on the line between townships one hundred and four (104) and one hundred and five (105), to its intersection with the western boundary of the State; thence due north, along said boundary, to the place of beginning.

That all acts or parts of acts inconsistent with SEC. 3. Repeal of acts' Inconvisiont with this act, be, and the same are hereby repealed.

This act shall take effect from and after its Seo. 4. passage.
