SIXTY-TWO, AND TERMINATING SEPTEMBER TWENTY-NINTH, ONE THOUSAND  
EIGHT HUNDRED AND SIXTY-TWO.

CHAPTER I.

*An Act to authorize the Commissioners of the County of  
Ramsey to issue bonds to fund the indebtedness of said  
County, incurred for military and other purposes.*

- SECTION 1. Commissioners authorized to issue bonds--for what purpose--at what rate of interest.
2. Tax to be levied for purpose of paying interest on bonds.
  3. Act, when to take effect.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the commissioners of Ramsey County be and they are authorized to issue bonds of said county in sums sufficient to fund the present indebtedness of said county incurred for military and all other purposes, said bonds to bear coupons attached bearing interest at the rate of seven per centum per annum, payable semi-annually, the principal to be paid at a period not exceeding twenty nor less than five years from the date of said bonds.

SEC. 2. That said commissioners have power to annually levy a tax upon the taxable property of said county

Interest how paid sufficient to pay the interest on such bonds and to create a sinking fund to pay the principal at the time of the maturity of such bonds, which shall be applied for no other purpose.

SEC. 3. This act to take effect and be in force from and after its passage.

Approved September 26th, 1862.

## CHAPTER II.

*An Act to legalize the action of the board of commissioners of the county of Dakota in issuing bonds for the payment of bounties to volunteers, and to provide for the levy of taxes to meet the interest and principal on the same.*

SECTION 1. Legalization and validity of action of board of commissioners.  
 2. To levy tax for purpose of paying interest on said bonds.  
 3. Act, when to take effect.

*Be it enacted by the Legislature of the State of Minnesota:*

Action of board of commissioners made legal and valid SECTION 1. That the action of the county commissioners of the county of Dakota in issuing bonds for the payment of bounties to volunteers, be, and the same is hereby legalized and made valid, and the payment of the interest and principal of the said bonds shall be binding upon the county of Dakota, the same as if the action of the said commissioners had been authorized by the Legislature.

Interest on bonds how paid SEC. 2. The board of commissioners of the said county of Dakota are hereby authorized and empowered to levy taxes upon the assessment roll for the year one thousand eight hundred and sixty-two, or any subsequent year or years thereafter, as the said commissioners may
