Anthorized to abate the taxes in certain coundiyohi, and Meeker, are hereby authorized to abate the taxes due on all real and personal property, within their respective counties, for the year 1862, that may be shown to the satisfaction of the County Commissioners of the proper county, to have been destroyed by the Indians or otherwise, during the Indian raid of 1862.

This act shall be in force from and after its

passage.

CHAPTER XXII.

An Act to Provide for the Assessment and Taxation of Property in the Counties of Brown and Watonwan, and for Levying Taxes thereon for the years 1862 and 1863.

SECTION 1. Duty of County Auditors in said counties.
2. Duty of Assessors.
3. Meeting of the County Board of Equalization—for what purpose.
4. Taxes for 1862 to be collected at the time and manner for 1863.
5. All general laws to remain in full force in said counties.
6. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That for the purpose of taxation of all the property in the counties of Brown and Watonwan. in the State of Minnesota, for the years 1862 and 1863, the auditors of said counties, shall, on or before the first Wednesday of May 1863, make and deliver to the respective assessors in said counties, the assessment rolls in the manner provided by the general laws of this State.

SEC. 2. That the assessors in said counties, shall then Duty of Assessors proceed to assess all the taxable property in said counties, and make their returns to their respective County Auditors on or before the first Monday of August, 1863.

SEC. 3. That the County Boards of Equalization for Meetlor of Board said counties, shall meet on the first Tuesday of Sep. of Equalization tember, 1863, for the purpose of equalizing the assess-for what purments for the years 1862 and 1863, in said counties.

That all the general laws in this State relating to the assessment and taxation of property, and the All general laws levy of taxes thereon, as well as to the duties of County to remain in full Auditors and County Treasurers, shall be and remain in full force and operation in said counties, as far as the same are not repealed or modified by this act.

CHAPTER XXIII.

An Act to Legalize and Confirm the Tax levied in Houston County, for county purposes, for the year 1862, by the Commissioners of said county, and to authorize the collection of the same.
