

posed: "Against change of county line." The vote shall be canvassed in the same manner, and returned to the same officers by judges of election of the several townships, as votes for State officers.

SEC. 3. The county officers in Todd and Morrison counties, to whom such returns are made, shall, within twenty days after said election, canvass the votes returned for and against said change of county line, and shall forthwith certify the result of such canvass to the Governor, who, if it appears that a majority of the voters in said counties, voting at said election, are in favor of a change of county line, shall make proclamation thereof, by publishing in a newspaper of Saint Paul, that the change proposed by this act has been ratified by a majority of the voters of Todd and Morrison counties, voting at said election.

Repeal of incon-
sistent acts

SEC. 4. All acts or parts of acts inconsistent with this act, are hereby repealed.

SEC. 5. This act shall take effect and be in force from and after its passage.

CHAPTER LXXIII.

An Act to amend an act entitled an act to incorporate the Sauk Rapids and Sauk River Manufacturing Company, approved May twenty-third, one thousand eight hundred and fifty-seven.

SECTION 1. When and where books to be opened for subscription to capital stock.
2. Definition of the term "structure."

Beit enacted by the Legislature of the State of Minnesota:

SECTION 1. That the incorporators or any one or

more of them named in the first section of said act may open books for the subscription of so much of the capital stock of said company as he or they may deem proper, at Sauk Rapids, St. Cloud, or St. Paul, at any time within one year from the passage of this act, by giving notice thereof at least four weeks in any newspaper published in Sauk Rapids or St. Cloud; and when the stock in said company has been taken in good faith, to an amount not less than twenty thousand dollars, the proceedings thereafter shall conform in all respects to the provisions of the act to which this is an amendment.

When and where books to be opened for subscription to capital stock

SEC. 2. *Be it further enacted*, That the term structures, in the eight section of said act, shall be construed to include the power and authority to erect a bridge across the Mississippi, on, above or below the falls at Sauk Rapids, "if, in the opinion of said company, such a structure" will facilitate or further its business or object, and said company may charge and receive reasonable tolls for travel over such bridge, to be regulated and collected, as fixed by its by-laws.

An Act to annex a portion of the Township of Carrollton, to the Township or Village of Preston.

SECTION 1. A portion of the town of Carrollton annexed to the town of Preston—for what purpose.
