

CHAPTER CVIII.

An Act to change the name of Charles H. Moore to that of Charles H. Eaton. March 2, 1865.

- SECTION 1. Change of name.
 2. Declared the legal heir of Charles Eaton.
 3. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the name of Charles H. Moore is hereby changed to that of Charles H. Eaton. Change of name.

SEC. 2. That the said Charles H. Eaton is hereby declared to be the legally adopted heir at law of Charles and Lucinda Eaton, of Winona, in the county of Winona, and State of Minnesota; and the said Charles H. Eaton shall be entitled to all the rights, privileges and inheritance as if he was the legitimate son of the said Charles and Lucinda Eaton. Declared legal heir of Charles Eaton.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER CIX.

An Act to change the name of Frederick Franklin Ball to that of Frederick Franklin Falsom, and the name of Ella Jane Ball to that of Ella Jane Falsom. March 2, 1865.

- SECTION 1. Change of names.
 2. Declared the legal heirs of John R. Falsom.
 3. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the name of Frederick Franklin

Change of name. Ball, be changed to that of Frederick Franklin Falsom, and the name of Ella Jane Ball, be changed to that of Ella Jane Falsom.

Declared legal heir of John R. Falsom.

SEC. 2. That the said Frederick Franklin Falsom and Ella Jane Falsom, be, and they are hereby declared to be the legally adopted son and daughter, and heirs at law of John R. Falsom, of the town of Eagle Creek, in the county of Scott, and State of Minnesota, and they shall enjoy all the rights and privileges, and be subject to all the duties and liabilities, as if they were the legitimate children of the said John R. Falsom.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER CX.

March 2, 1865.

An Act to change the name of Gustof Johnson to that of Gustof J. Vieburg.

SECTION 1. Change of name.

2. When act to take effect.

Beit enacted by the Legislature of the State of Minnesota :

Change of name.

SECTION 1. That the name of Gustof Johnson, living in the town of Chisago Lake, Chisago county, be and the same is hereby changed to that of Gustof J. Vieburg.

SEC. 2. This act shall take effect and be in force from and after its passage.
