

## CHAPTER XLVII.

March 2, 1895.

*An Act to locate a State Road from Anoka, in Anoka county, to Sunrise City, in Chisago county.***SECTION 1.** Commissioners appointed—for what purpose.

2. When and where to meet—may appoint substitutes.

*Beit enacted by the Legislature of the State of Minnesota :*

Commissioners appointed—for what purpose.

**SECTION 1.** That E. T. Alling, Franklin Whitney and Stephen Hewson, be and are hereby appointed commissioners to locate, mark, survey and establish a State road from Anoka, in Anoka county, by way of Cedar Grove, Bethel, Linwood, Oxford and North Branch to Sunrise City, in Chisago county.

When and where to meet—may appoint substitutes.

**SEC. 2.** The said commissioners, or a majority of them, shall meet in the town of Anoka, on the last Monday of March next, and then proceed to locate and survey said road, and in case all of said commissioners should not be in attendance on the day as provided in this section, it shall be the duty of the commissioners that may be in attendance on the day so specified, to appoint substitutes.

Expenses, how paid.

**SEC. 3.** The expenses incurred in the establishing and surveying of said road shall be paid by the several counties through which the road may pass, in proportion to the length of such road in said counties.

Compensation.

**SEC. 4.** The said commissioners, one chainman and one axeman, shall receive each two dollars and fifty cents per day, and the surveyor the sum allowed by law for the number of days employed by them under the provisions of this act.

To file plat of road

**SEC. 5.** The map or plat, or survey of said road shall be filed by said commissioners in the offices of the several registers of deeds of the counties through

which the road may pass, on or before the first day of November, eighteen hundred and sixty-five.

SEC. 6. This act shall take effect from and after its passage.

### CHAPTER XLVIII.

*An Act to locate a State road from Cambridge, in Isanti county, to Elk River, in Sherburne county.*

March 2, 1865.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That Barton A. Latta, Moses N. Emerson and Benjamin N. Spencer are hereby appointed commissioners to locate, mark, survey and establish a State road from Cambridge, in Isanti county, by way of Spencer Brook to Elk river, in Sherburne county.

SEC. 2. That said commissioners, or a majority of them shall meet on the first day of May next, at Elk river, and then proceed to locate and survey said road, commencing at or near the railway depot in said town, running thence upon the present travelled road, north, about six miles, thence bearing a northeast course until striking the government road near to Spencer brook, and thence by the most feasible route to Cambridge.
