CHAPTER LXXXIV.

An Act to attach the county of Jackson to the county of February 16, 1965. Martin for judicial purposes.

SECTION 1. Attached to Martin county for judicial purpose 2. Repeal of inconsistent acts-when act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The county of Jackson is hereby attached to the county of Martin for judicial purposes, Attached to Martin for judicial purposes, county for judicial and all judicial officers of said county of Martin shall purposes. have and exercise full jurisdiction, power and authority over and act in and for said county of Jackson, as if it was a part of said county of Martin.

SEC. 2. All acts and parts of acts inconsistent with this act are hereby repealed, and this act shall take Repeal of incomeffect and be in force from and after its passage.

CHAPTER LXXXV.

An Act to amend an act entitled "an act to attach the February 25, 1866. county of Manomin to the county of Hennepin for judicial purposes, passed March fifth, eighteen hundred and sixty-three.

· Be it enacted by the Legislature of the State of Minnesota:

Section 1. That section one, chapter sixteen, of

the act to attach the county of Manomin to the county of Hennepin for judicial purposes, passed March fifth, eighteen hundred and sixty-three, be amended so as to read as follows:

Attached to the county of Hennepin for judicial purposes. Section 1. The county of Manomin is hereby attached to the county of Hennepin for judicial purposes, and all judicial officers, justices of the peace, constables and deputies of said county of Hennepin shall have and exercise full jurisdiction, power and authority over, and act in, and for said county of Manomin, as if it were a part of said county of Hennepin.

SEC. 2. This act shall be in force and take effect

from and after its passage.

CHAPTER LXXXVI.

An Act to authorize Martha P. Robson, Administratrix of James A. Robson, deceased, to convey the real estate of said deceased at private sale.

SECTION 1. Authorizing the Administratrix to convey the real estate of said deceased person.

2. When act to take effect.

Be itenacted by the Legislature of the State of Minnesota:

Authorising said administratrix to convey said estate.

SECTION 1. Martha. P Robson, administratrix of the real estate of James A. Robson, deceased, of Freeborn county, is hereby authorized and empowered to bargain, sell, convey in fee simple or otherwise, at private sale, as administratrix of the estate of James A. Robson, aforesaid, any or all of the real estate of said James A. Robson, to such person or persons, their heirs or assigns, on such time and credit and for such
