### OHAPTER CI.

## An Act to locate and establish a State road from Wilton, March 1, 1886. in Waseca county, to Winnebago City in Faribault county.

SECTION 1. Nominates commissioners to locate State read from Wilton to Winnebago City.

- 2. Place and time of meeting of Commissioners.
- 3. Commissioners may employ surveyor, etc.
- 4. Commissioners to appraise damages. To file plat.
- 5. County Commissioners may allow or reject proposals.
- 6. When act to take effect.

#### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That H. A. Buck, N. J. Kremer and J. Nominates Com-B. Hill are hereby appointed commissioners to locate, missioners. survey and establish a State road from Wilton, in Waseca county, to Winnebago City, in Faribault county.

SEC. 2. The commissioners shall meet at such place Commissioners as may be most convenient, on any day subsequent to to hold meeting. the passage of this act, and proceed to discharge the duties imposed on them by the provisions of this act; *Provided*, That in the absence of any one of said commissioners the other two shall have power to fill said vacancy by the appointment of some suitable person, who shall have the same authority as is by this act conferred upon said commissioners above named.

SEC. 3. The said commissioners are hereby empow- May appoint offered to employ one surveyor, two chainmen and one care. axeman.

SEC. 4. It shall be the duty of the said commission- Duty of Commisers to appraise the damages sustained by each owner stoners. of land through which said road shall run, and report the same to the board of county commissioners of the county in which said lands are located. Said commissioners shall cause an accurate plat and maps of the survey and location of said road to be made, which together with a statement of their appraisal of damages, shall be filed in the office of the county auditor in each of said counties, and thereupon the establishment of said road shall be deemed complete.

Further dutics.

SEC. 5. It shall be the duty of said county commissioners to examine any appraisals, and allow or reject the same, as they in their judgment may think best.

Expenses—How defrayed.

SEC. 6. The expenses of surveying, locating and establishing said road, and the damages, if any, shall be paid by the several counties through which said road shall run, in proportion to the distance it shall run in said counties.

SEC. 7. This act shall take effect from and after its passage.
