

CHAPTER CXI.

An Act for the relief R. H. Bennett, J. B. Fish and S. R. Randolph. February 28, 1866

SECTION 1. Selection of swamp lands—authorizes certain parties to make selection.

1. Governor to make conveyance of said lands.
2. Governor to appoint commissioners.
3. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That R. H. Bennett, J. B. Fish and S. R. Randolph, or their assigns, be and they are hereby authorized to select ten thousand acres of swamp lands within this State, under and pursuant to section 2, of an act entitled "an act to provide for the location and construction of a State road from Madelia, in Watonwan county, to a point on the western boundary of the State," approved March 1, 1862. Selection of land.

SEC. 2. That when such selection of swamp lands shall have been made, as above provided, the Governor of the State shall, and he is hereby authorized and empowered for and in behalf of the State, to convey to said R. H. Bennett, J. B. Fish and S. R. Randolph, or to their assigns, by sufficient deeds of conveyance, the lands selected as above provided. *Provided, however,* that before the execution of the deeds of conveyance, above referred to, the Governor of the State shall be satisfied that said R. H. Bennett, J. B. Fish and S. R. Randolph have constructed the State road from Madelia to the western boundary of the State in accordance with the terms of the act of the legislature referred to in section one of this act. Governor may convey lands.

SEC. 3. The Governor is hereby authorized to appoint three commissioners, whose duty it shall be to make a personal examination of the road aforesaid, and report the result of such examination to the Governor, on or before the first day of July, 1866, how Governor to appoint Commissioners.

much of said work has been done, and in their judgment what proportion of said land, if any, said Fish, Bennett and Randolph are entitled to for the same. *Provided*, The expenses incurred in making such examination shall be paid by the said R. H. Bennett, J. B. Fish and S. R. Randolph, in whole or in part in the discretion of the Governor, and a sum sufficient for this purpose shall be deposited by the said Fish, Bennett and Randolph with the Governor, before the appointment of such commissioners.

SEC. 4. This act shall take effect from and after its passage.

CHAPTER CXII.

February 2, 1866 *An Act to repeal Chapter twenty-five of the Session Laws of eighteen hundred and fifty-five.*

SECTION 1. Repeals a certain ferry charter.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Repeal of Char-
ter.

SECTION 1. That chapter twenty-five of the session laws of eighteen hundred and fifty-five, entitled "A bill granting to William H. Oliver the right to establish and maintain a ferry across Lake Saint Croix," be and the same is hereby repealed.

SEC. 2. This act shall take effect and be in force from and after its passage.
