## CHAPTER XCIV.

An Act to provide for the location of a State Road February 29,1866
from Forest City, in Meeker county, to Norway
Lake, in Monongalia county.

Snorrow 1. Locates State Road from Forest City to Norway Lake—nominates commisstoners for that purpose.

- 2. Commissioners to meet.
- 3. How expense of locating road to be defrayed.
- 4. Commissioners to file plat of road.
- 5. When act to take effect.

## Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. William H. Greenleaf, James B. Atkin-Appoints Comson, and Ole Halverson Ness, are hereby appointed missioners to survey, locate and lay out a State road from Forest City, in the county of Meeker, via Swede Grove, Diamond Lake, and Green Lake, to Norway Lake, in Monongalia county.

SEC. 2. Said Commissioners may meet at Forest Expenses—how City on any day subsequent to the passage of this act, pald. and proceed to discharge the duties imposed upon them by the provisions of this act; and if any one of said commissioners shall be unable to act as such, the other two commissioners shall have power to appoint a substitute.

SEC. 3. Each county through which such road Time and place passes, shall pay the reasonable expenses of locating of meeting. the same in such county. *Provided*, That no county shall be liable to pay such expenses unless the board

of commissioners of such county shall assent thereto before such location.

Plat to be filed.

SEC. 4. The commissioners hereby appointed shall, as soon as practicable after locating said road, file an accurate plat of the same in the office of the Register of Deeds in each county in which it may run, which said plat shall be the legal evidence of the location of the said road.

Sec. 5. This act shall take effect and be in force from and after its passage. .

## CHAPTER XCV.

Yebruary 28, 1888 An Act to locate a State Road from Hutchinson, in McLeod County, to Kingston, in Meeker County.

SECTION 1. Authorizes location of State Road from Hutchinson to Kingston.

- 2 Commissioners to meet for discharge of duties.
- 3. Commissioners may employ surveyor, etc.
- 4. Commissioners to file plat of road.
- 5. How expenses to be defrayed.

Be it enacted by the Legislature of the State of Minnesota:

Appoints Commissioners. Section 1. Charles F. Davis, Lewis King and Lewis Harrington are hereby appointed commissioners to locate and survey a State road from Hutchinson, in Mc-Leod county, to Kingston, in Meeker county.

Place of meeting

SEC. 2. The commissioners shall meet at such place as may be most convenient, on any day subsequent to the passage of this act, and proceed to discharge the duties imposed on them by the provisions of this act.

SEC. 3. The commissioners are hereby empowered
