#### CHAPTER XCVIII.

An Act to provide for the location and construction of February 28,1805 a State Road from Beaver Bay to Vermilion Lake.

SECTION 1. Nominates three Commissioners to locate a State Road from Beaver Bay in Vermillon Lake.

- 2. Expense of location-how defrayed.
- 3. Notes and maps to be filed with Register of Deeds.
- 4. When act to take effect.

### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That Christian Wieland, Henry Wie-Nominates Com+ land and Ernst Wieland be and are hereby appointed missioners. commissioners to survey, locate and construct a State road, commencing at Beaver Bay, in Lake county, and thence in the nearest and most practicable route to a point on Lake Vermilion, in Saint Louis county, by doing all necessary clearing and grubbing, corduroying, bridging, and all other work necessary for the convenience and safety of transit for stage coaches.

SEC. 2. All the expenses in surveying, locating and Expenses-how constructing said State Road shall be paid by said defrayed. commissioners, who shall have the right to erect one or more toll gates upon said road, and demand and receive toll in the same manner as provided by law in reference to plank roads: Provided, however, That the rates of toll shall be reasonable—shall in no instance exceed those fixed by law for plank roads, and may be regulated by the county commissioners of those counties through which said State road may pass: And provided further, That the county commissioners of those counties through which said State road shall pass, shall have the right to purchase the same on account of such counties, from said commissioners or their assigns, for the purpose of opening said road free of any toll for the public, by paying the Expenses for surveying, locating and constructing said coad, with seven per cent. interest per annum.

Plat to be filed.

SEC. 3. All the field notes and maps of said road shall be filed with the register of deeds of Saint Louis county, and a copy thereof in the State bureau of public lands.

SEC. 4. This act shall take effect and be in force from and after its passage.

#### CHAPTER XCIX.

# March 1, 1866. An Act to lay out a State Road from Twin Lakes and Du Luth to Vermilion Falls.

SECTION 1. Nominates three Commissioners to lay out State Read from Du Luth to Vermilion Falls.

## Be it enacted by the Legislature of the State of Minnesota:

Nominates Commissioners.

SECTION 1. That E. F. Ely, Sydney Luce and George E. Wheeler are hereby appointed commissioners to lay out and establish a State road from Twin Lakes, in the county of Carlton, and from Du Luth, in the county of St. Louis, to some convenient point of intersection, and from thence by the nearest [and] most feasible route to the Vermilion Falls, near the head of Lake Vermilion, in the county of St. Louis.

Commissioners to hold mestings.

SEC. 2. The commissioners hereby appointed may meet at any time after the passage of this act and proceed to lay out said road, and after the same is surveyed shall cause a map thereof to be filed in the office of the Secretary of State, and a duplicate thereof
