CHAPTER CXXIX.

An Act to provide for the location of a state road from March 9, 1867

Lake City, in Wabasha county, via Plainview, to Saint Charles, in Winona county.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That Asa B. Doughty, Jabez N. Collins Commissioners and C. W. Hackett, of the town of Lake City aforesaid, are hereby appointed commissioners to survey, locate and establish a state road from some point to be by them selected, in the village of Lake City, running thence by the most feasible route by the way of Plainview, in said Wabasha county, to Saint Charles, in Winona county.

Sec. 2. That said commissioners shall meet at such time and place as shall be convenient to them and pro- Organization] coed to discharge the duties imposed upon them by this act; Provided, That if either of said commissioners shall be unable to discharge said duties he shall have power to substitute some person to act in his place, and such action by such substitute shall have the same effect as if he were appointed commissioner by this act.

Sec. 3. That said commissioners are hereby authorized to employ a surveyor, axman and chainman, and eletants it shall be their duty to cause said road to be accurately surveyed and platted, and file a copy thereof in the office of the register of deeds in each county through or into which said road may pass.

SEC. 4. That each county through or into which said Expenses road shall pass shall pay the expense of the location thereof in proportion to the distance it may run in each

county; Provided, That the commissioners shall not receive more than three dollars per day and their necessary expenses.

When establish'd

- SEC. 5. That such road shall be deemed established and opened upon filing the survey and plat thereof, which plat shall be legal evidence of the location and existence of said road.
- SEC. 6. This act shall take effect and be in force from and after its passage.

CHAPTER CXXX.

February 28 '67

An Act to repeal an act entitled an act to locate, establish and survey a state road from West Saint Paul, in the county of Dakota, to Belle Plaine, in the county of Scott.

SECTION 1.—Repeals chapter 109, of special laws of 1866. 2.—When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That chapter one hundred and nine of the special laws of the year 1866, being "an act entitled an act to locate, establish and survey a state road from West Saint Paul, in the county of Dakota, to Belle Plaine, in the county of Scott," be and the same is hereby repealed, and the road and every part thereof surveyed, located and established under said act is hereby vacated.

SEC. 2. This act shall take effect and be in force from and after its passage.
