CHAPTER XXVII.

March 7, 1867. *An Act to authorize the filing and recording a plat of the original town of Hastings, in the office of the register of deeds of Dakota county, and to give the same effect as evidence.*

SECTION 1.—Register of Deeds to file plat of original town.

2.—Plat to be public record.

3.—When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Filing plat

SECTION 1. The register of deeds of the county of Dakota is hereby authorized to file a record in his office a certain plat of the original town of Hastings, made under the directions of the city council of the city of Hastings, by L. L. L. Bassford, civil engineer, together with his certificate thereon, dated February 12, 1867, which said plat is styled, "Map of the original town of Hastings.

To be recorded

SEC. 2. That said plat, when so filed and recorded, is to be a public record, and shall be deemed and taken to be a correct plat of said original town of Hastings, and the record of the same shall have the same effect as other public records, and certified copies thereof shall be admissible in evidence in all courts of this state, as well as said original plat and the record thereof: *Provided*, that this act shall not effect in any way rights already vested.

SEC. 3. This act is a public act and shall take effect and be in force from and after its passage.

CHAPTER XXVIII.

An Act to amend an act entitled "An Act to incorporate the Borough of Henderson, in the county of Sibley, approved January 23d, 1866.

March 6, 1867.

- SECTION 1.—Amends original act by further regulating licensing powers, etc.
- 2.—Regulates how the cost of public improvements is to be defrayed.
- 3.—Defines what property subject to taxation and limits the sale thereof.
- 4.—When act to take effect.

Powers of council

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Sections eighteen (18) twenty (20) and twenty-three (23) of an act entitled "an act to incorporate the borough of Henderson, in the county of Sibley, approved January 23d, 1866, are hereby amended so as to read as follows: *Section 18.* The council shall have power, 1st, To license and regulate the exhibition of common showmen and shows of all kinds, and the exhibition of circuses, concerts and theatrical performances, auction stores, lotteries, billiard tables, pigeon-hole tables, nine or ten-pin alleys, bowling saloons, butchers' shops, groceries, taverns, lager-beer saloons, and persons vending, dealing in or disposing of spirituous, vinous, malt or fermented liquors.

2d. To restrain any persons from vending, giving, or dealing in spirituous, vinous, malt or fermented liquors, unless duly licensed by the borough council.

3d. To prevent and punish horse-racing, immoderate riding or driving in the streets; to compel persons to
