

or so much thereof as may be necessary, is hereby appropriated, to be expended in the erection of a building for a hospital for the insane of the state of Minnesota, the same to be paid on warrants drawn by the president and countersigned by the secretary of the board of trustees of that institution, and that on the presentation of such warrants on the state auditor, it shall be his duty to draw warrants on the state treasurer for like amount, such money to be expended under the direction of the board of trustees of the hospital for the insane for the state of Minnesota, as provided by law.

CHAPTER CXIX.

An Act to provide for an appropriation of money for the benefit of the Deaf and Dumb, and Blind Institute.

March 6, 1869.

SECTION 1. Appropriation for the benefit of the Deaf and Dumb, and Blind Institute.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The sum of seven thousand five hundred dollars is hereby appropriated out of any money in the treasury not otherwise appropriated, for the purpose of supplying the deaf and dumb and blind asylum with water and light and school rooms and chapel furniture, for grading the grounds belonging to said institute, and fences, barn and out buildings for the same, the said money to be expended under the direction of the board of directors of the said institution, and the state auditor is hereby directed to draw warrants for said amount upon the certificates of the governor or president of said board of directors.

CHAPTER CXX.

March 6, 1868.

An Act to amend an act entitled an act, to appropriate money for the erection of a building for the State Normal School at Winona, approved March seventh, eighteen hundred and sixty seven.

SECTION 1. Appropriation for the erection of building for State Normal School.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That section one of an act entitled an act, to appropriate money for the erection of a building for the state normal school at Winona, approved March seventh, eighteen hundred and sixty-seven, be and the same is hereby amended by adding at the end of said section one, the following proviso: *Provided further*, That from and after the passage of this act, no more money shall be drawn from the treasury of the state under the provisions of this act, until the city of Winona shall make provision for the payment of fifteen thousand dollars, to the treasurer of the state normal school board, to be used in the erection of said buildings in a manner satisfactory to said board, which fact shall be evidenced by the certificate of the president of said board certifying that such provisions has been made, which certificate shall be filed with the state auditor, and that after such certificate is so made and filed, the money remaining undrawn from the treasury of the state, may be drawn therefrom under and in pursuance of the provisions of this act in all respects, as though this provision had not been passed.
