May nineteenth A. D. one thousand eight hundred and fifty-seven, and of the act amendatory thereof approved February twenty-seventh, one thousand eight hundred and sixty-seven, and that all and singular, the trusts, any property conferred upon or held by said former trustees under the act of congress entitled "an act for the relief of citizens of towns upon the lands of the United States under certain circumstances, passed May twenty-third, one thousand eight hundred and fifty-four, and under the said amendatory act, and shall vest in said trustees so to be elected who shall have all the powers and perform all and singular, the duties provided by said act of congress and of chapter forty-two of the general statutes relating to official trusts, and in case the notices provided in section three of said chapter, shall not have been given as therein provided, then the trustees so to be elected may give such notice, and proceedings may thereupon be had in all respects as are authorized by said chapter, and with like, legal effect and validity.

SEC. 2. This act to take effect and be in force from and after its passage.

## CHAPTER XLVII.

An Act in addition to the acts relating to the town of Fond du Lac, in St. Louis county.

March 5, 1868.

SECTION 1. What to constitute the Council of said Town-powers of Town Council.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the trustees of the town of Fond du' Lac, to be elected on the third Tuesday in March eighteen hundred and sixty-eight, and their successors in office

shall constitute the town council of said town, and as such shall be invested with the title of all real estate heretofore conveyed to the present or former trustees of said town, in trust, whether the same be included within or without the limits of the three hundred and twenty acres specified in the act of February twenty-seventh, eighteen hundred and sixty-seven, and that said trustees in the name of said town of Fond du Lac, may convey in tee simple all tracts and parcels not embraced within any street, alley or public ground, and to which no valid claim of title adverse to said town, shall be established or which may not be claimed and conveyed under the provisions of the chapter relating to official trusts, the proceeds of all such sales to be expended by said town council in the improvement of the streets of said town.

## CHAPTER XLVIII.

March 4, 1868.

An Act to perfect and legalize the plat of the city of Stillwater, in the county of Washington, and state of Minnesota.

Section 1. City Council empowered to cause the plat of said city to be perfected—how.
