CHAPTER LXII.

March 2, 1968.

An Act to legalize and confirm the acts, resolutions and proceedings of certain Special School Meetings held in School District Number Seventy (70), in the County of Winona.

- SECTION 1. Confirmation of proceedings and resolutions in regard to the building of a school house in said district.
 - Said school house declared to be the district school house—expense incurred in the erection, how paid.
 - Trustees authorized to keep and maintain a public school to be kept in said school house.
 - 4. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

In regard to the building of a school house.

Section 1. That the acts, proceedings and resolutions in regard to the building of a school house in school district number seventy (70), in the county of Winona, adopted by the qualified voters of said district at certain special school meetings held in the aforesaid school district in the months of November and December, one thousand eight hundred and sixty-seven, at the house of John Nagle, in said district, pursuant to notice given according to law, are hereby confirmed, made valid and declared to be legal in all respects.

To be a district school house expense, how paid. SEC. 2. That the school house erected and built in the aforesaid school district, in and by virtue of the acts, resolutions and proceedings adopted at the special school meetings mentioned in section one of this act, authorizing the building of the same, is hereby declared to be the district school house in and for the said school district, and the expenses incurred in the erection and building of the same shall be paid by the said school district number seventy (70) of Winona county.

Trustoes to keep a public school in said school house.

SEC. 3. The trustees of the aforesaid school district are hereby authorized and required to keep and maintain the public schools in and for the said district in the district school house mentioned in section two (2) of this act.

SEC. 4. This act shall take effect and be in force from whomactional and after its passage.
