Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the following sums of money, or so much thereof as may be necessary, be, and the same are hereby appropriated out of any moneys in the state treasury Appropriations belonging to the general revenue fund, not otherwise for the general appropriated, for the general expenses of the state govern-government. ment for the year one thousand eight hundred and sixtynine (1869) hereinatter specified, viz:
