CHAPTER CXXVI.

Feb'y 23, 1869. An Act to amend and continue the act entitled An Act to incorporate the Stillwater Ferry Company.

SECTION 1. The provisions of the act approved March 2d, 1855, granting said charter are hereby continued in full force.

> 2. The rights and powers are hereby transferred and vested in James S. Anderson-for what length of time continued.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That all and singular the provisions of the Former act con-tinued in force, act of the legislative assembly of the territory of Minnesota, entitled "An act to incorporate the Stillwater ferry company," approved March second (2d), one thousand eight hundred and fifty five, be and the same are continued in full force, and the same are confirmed to said corporation, its successor and assigns in all respects, except only in so far as the same is modified, amended or changed by the provisions of this act.

> That the rights and powers conferred upon SEC. 2. Isaac Staples, John McKusick, Christopher Carli, Elias McKean, Jonathan E. McKusick and Albert Harris, and their associates and assigns, be and the same are continued to and vested in James S. Anderson, the successor in interest of said corporators and their associates, successors and assigns. That said James S. Anderson, his successors or assigns, so invested with rights, franchises and privileges, shall continue, with the same powers and privileges conferred that are contained in the act to which this is an amendment, and be subject to the same penalties,

CHAPTER CXXVII.

An Act to amend Section one, of Chapter one hundred and seventeen, of the Special Laws of the year one thousand. eight hundred and sixty-eight, relating to the Minnesota Mining Company.

SECTION 1. Amendment to Section one (1) of Chapter one hundred and seventeen (117) of the Special Laws of 1868. Board of incorporators-name and style of said corporation.

9. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one, of chapter one hundred and seventeen, of the special laws of the year one thousand eight hundred and sixty-eight, be amended so as to read as follows:

Sec. 1. That Rubin Haus, J. P. Wilson, E. C. Becker, Orrin W. Rice, J. C. Moulton, Orrin Curtis, Ross Wilkinson, George F. Brott and their associates, shall be and are hereby constituted and made a body politic and cor-porators, by the name and style of the "Burnt Rock Mining and style of said Company," and by that name shall be capable in law of sueing and being sued; pleading and being impleaded; answering and being answered; defending and being defended in all courts and places whatsoever in all manner of actions, suits, complaints, matters and causes whatever, may have a common seal, and alter the same at pleasure, and by said name may be capable of purchasing, holding and conveying any estate or property, personal, real or mixed, for the benefit or use of said corporation.
