CHAPTER CXXVII.

An Act to amend Section one, of Chapter one hundred and seventeen, of the Special Laws of the year one thousand. eight hundred and sixty-eight, relating to the Minnesota Mining Company.

March 8, 1869.

- SECTION 1. Amendment to Section one (1) of Chapter one hundred and seventeen (117) of the Special Laws of 1868. Board of incorporators-name and style of said corporation.
 - 2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That section one, of chapter one hundred and seventeen, of the special laws of the year one thousand eight hundred and sixty-eight, be amended so as to read as follows:

Sec. 1. That Rubin Haus, J. P. Wilson, E. C. Becker, Orrin W. Rice, J. C. Moulton, Orrin Curtis, Ross Wilkinson, George F. Brott and their associates, shall be and are hereby constituted and made a body politic and corporators—name porate, by the name and style of the "Burnt Rock Mining and style of said Company," and by that name shall be capable in law of sueing and being sued; pleading and being impleaded; answering and being answered; defending and being defended in all courts and places whatsoever in all manner of actions, suits, complaints, matters and causes whatever, may have a common seal, and alter the same at pleasure, and by said name may be capable of purchasing, holding and conveying any estate or property, personal, real or mixed, for the benefit or use of said corporation.

Said corporation may elect in such manner as they may determine, all necessary officers, fix their compensation, and define their duties, ordain and establish by-laws for the proper government and regulation of the officers of the said company, and alter and repeal the same, and employ all such agents, mechanics and laborers as they may deem proper.

When act to take effect.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CXXVIII.

March 9, 1849. An Act to amend an act entitled "An Act to grant the right to certain persons to establish and maintain Ferries in this Territory," approved March first, one thousand eight hundred and fifty-six.

SECTION 1. Extension of time granted for sustaining and maintaining said forry.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Extension of said ferry.

SECTION 1. That subdivision eight, of section one, of time granted for the act referred to in the title to this act, be and the same hereby is amended so as to extend the time wherein the ferry referred to in said subdivision may be kept and maintained by Thomas A. Holmes, therein named, or his assignees, for and during the further term of fifteen years, from the passage of this amendment, subject however, to a compliance with the duties, obligations and liabilities imposed and granted by said act.

When act to take effect.

This act shall take effect on and after its approval by the governor.
