## CHAPTER CXXXVI.

Feb'y 24, 1869.

*An Act to amend the Act entitled "A bill to incorporate the Western Land Association," approved May twenty-third, one thousand eight hundred and fifty-seven.*

- SECTION 1. Amendment to Section three (3) of the act approved May 23d, 1857. Where principal office of said Company located—how questions at meetings of stockholders to be determined.
2. Amendment to Section five (5) of said act. Where Board of Directors may meet—to elect or appoint agents for the transaction of the business of said Association—when agents may sell and convey real estate—such power of attorney shall be conclusive evidence of the authority of such agent.
3. All acts of said Association heretofore done not inconsistent are declared valid.
