

## CHAPTER X.

March 1, 1870.

*An Act to Apropriate money for the use and benefit of the  
Second State Normal School at Mankato.*

- SECTION 1. Appropriation for the purpose of purchasing the necessary heating and ventilating apparatus, completing basement, building outbuilding, &c.
2. Said sum to be expended under the direction of the Normal School Board—when warrants may be drawn,
  3. Repeal of inconsistent acts.
  4. When act to take effect.

*Be it enacted by the Legislature of the State of Minnesota :*

Appropriation to  
purchase heating  
apparatus, &c.

SECTION 1. The sum of twelve thousand five hundred dollars, in addition to former appropriations, or so much thereof as may be necessary, is hereby appropriated out of any money in the treasury not otherwise appropriated, for the purpose of purchasing and introducing the necessary heating and ventilating apparatus, completing basement, building out buildings, drainage, digging well and building cistern, with fixtures for the same, fencing and grading grounds, flagging walks, painting roof, and securing such further conveniences and changes in the construction and completion of the building for said Second State Normal School at Mankato, as in the opinion of the normal school board are necessary.

SEC. 2. The said sum of money so appropriated, shall be paid on warrants drawn by the president of the state normal board of instruction, and countersigned by the secretary thereof, and upon the presentation of such warrants to the auditor of state, he shall draw warrants on the state treasury for the amount named in the warrants of said president and secretary, not exceeding in all, the amount by this act appropriated, and to be expended under the direction of the normal school board, as provided by law; *Provided*, That the warrants provided for in this section shall not be drawn before the first of July next.

SEC. 3. All acts and parts of acts inconsistent with this act are hereby repealed. Repeal of inconsistent acts.

SEC. 4. This act shall take effect and be in force from and after its passage. When act to take effect.

## CHAPTER XI.

*An Act to appropriate money for the improvement of the State Prison, Deficiencies, Salaries, Current Expenses, Repairs, &c.* March 4, 1870.

SECTION 1. Appropriation for the improvement of the State Prison, deficiencies, salaries, current expenses, repairs, &c.

1. For salaries of officers for 1869, deficiency.
  2. For current expenses for 1870.
  3. For salaries of officers.
  4. Deficiency for surveying and platting grounds, &c.
  5. For deficiency for land bought in 1869.
  6. For building cells, &c.
  7. For new roof for shop.
2. Said sums to be expended under the direction of State Prison Inspectors.
3. When act to take effect.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the following sums of money, or so much thereof as may be necessary, be, and the same are hereby appropriated out of any money in the treasury belonging to the general revenue fund not otherwise appropriated: Appropriation—  
for what purpose.

*First*—Five hundred and fifty dollars deficiency for salaries of officers for one thousand eight hundred and sixty-nine.

*Second*—Fifteen thousand dollars for current expenses for one thousand eight hundred and seventy.
