

CHAPTER CVII.

March 4, 1870.

*An Act to appropriate money for certain purposes therein named.***SECTION 1.** Appropriations for certain purposes therein named.

1. To supply a deficiency for 1869 in conveying convicts to State Prison.
2. For printing Laws and Journals, 1869—deficiency.
3. For printing and advertising for the several departments, 1869—deficiency.
4. For addition to artillery house.
5. For carpet furnished office of Secretary of State and Clerk of Supreme Court.
6. For expenses incurred by the State Board of Equalisation.
7. For certified lists of swamp lands.
8. For services rendered in the office of State Auditor.
9. For repairing, cleaning and furnishing House and Senate Chambers.
10. For powder furnished State Arsenal.
11. For teams to Stillwater.
12. For teams to Stillwater.
13. For teams to State Reform School.
14. For board for teams and drivers.
15. For balance of claim for lighting the Capitol.
16. For repairing and lighting State Library.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the following sums of money, or so much thereof as may be necessary, be and the same are hereby appropriated out of any money in the treasury belonging to the general revenue fund not otherwise appropriated:

First—To supply a deficiency in the appropriation of one thousand eight hundred and sixty-nine for conveying convicts to state prison and returning fugitives from justice, one hundred and seventy-one dollars and seventy-one cents (\$171.71.)

Second—To supply a deficiency in the appropriation of

one thousand eight hundred and sixty-nine for printing laws and journals, three hundred and fifty dollars and seventy-four cents (\$350.74.)

Third—To supply a deficiency in the appropriation of one thousand eight hundred and sixty-nine for printing and advertising for the several departments, one thousand dollars (\$1,000.)

Fourth—To Thomas Fitzpatrick for addition to artillery house, one hundred and seventy dollars and thirteen cents (\$170.13.)

Fifth—To R. O. Strong & Co., for carpets furnished office of secretary of state and clerk of supreme court, two hundred and four dollars and three cents (\$204.03.)

Sixth—For expenses incurred by the state board of equalization eighteen hundred and sixty-nine, one hundred dollars (\$100.)

Seventh—To C. F. Jerome for certified lists of swamp lands, five hundred and twenty-five dollars (\$525.)

Miscellaneous
appropriations.

Eighth—To Thomas F. Masterson, services rendered in the office of state auditor from December first, one thousand eight hundred and sixty-nine to January fifteenth, one thousand eight hundred and seventy, one hundred and fifty dollars (\$150.)

Ninth—To Fred. Otto for repairing, cleaning and furnishing house and senate chambers for the twelfth session of the legislature, three hundred and fifty-six dollars and forty-seven cents (\$356.47.)

Tenth—To M. Ryder for powder furnished state arsenal, fifty-five dollars (\$55.)

Eleventh—To S. C. Whitcher for teams to Stillwater \$70.00.

Twelfth—To Cook & Webb for teams to Stillwater \$70.00.

Thirteenth—To Cook & Webb for teams to State Reform School \$67.00.

Fourteenth—To E. R. Smith for board for teams and drivers at Stillwater \$28.50.

Fifteenth—To St. Paul Gas Company for balance of claim for moneys by them expended in lighting the capitol building with gas \$250.00.

Sixteenth—For repairing and lighting state library \$300.00.

SEC. 2. This act shall take effect and be in force from and after its passage.
