CHAPTER XC.

Pad's 18, 1870. An Act to establish the County of Swift and to define the boundaries thereof.

- SECTION 1. Defines boundary lines of Swift County.

Be it enacted by the Legislature of the State of Minnesota:

Boundary lines of Bwift county.

Section 1. The boundary lines of Swift county are hereby established and hereafter shall be as follows: Beginning at the north-east corner of township number one hundred and twenty-two north, of range number thirty-seven, west of the fifth principal meridian, thence west to the north-west corner of township number one hundred and twenty-two north, of range number forty-three west, thence south to the centre of the main channel of the Minnesota river, thence in a south-easterly direction along the main channel of said river to the intersection of the township line between townships one hundred and nineteen and one hundred and twenty, thence east along said township line to the south-east corner of township number one hundred and twenty, range number thirty-seven, thence north to the point of beginning.

To be submitted to the people—when—ballots how prepared—election how conducted.

SEC. 2. At the time of giving notice of the next general election, it shall be the duty of the officers of the county of Chippewa required by law to give notice of such election, to give notice in like manner, that at said election a vote will be taken on the question of changing the boundary lines of Chippewa county in accordance with the provisions of this act. At said election the voters of said county of Chippewa in favor of the change proposed by this act, shall have distinctly written or printed, or partly written or

printed on their ballots, "for change of boundary lines of Chippewa county in favor of Swift county," (and those opposed to said change,) "against change of boundary lines of Chippewa county," and returns thereof shall be made to the same officer by the judges of election of the several townships, and by the auditor of said Chippewa county as votes for state officers.

Sec. 3. The county seat of said county of Swift is hereby established at Benson, on the south-west quarter where county of section number five, township number one hundred and twenty-one north, of range number thirty-nine, west of the fifth principal meridian.

SEC. 4. The county of Swift is hereby attached for Attached to Pope
